

## **VELOCOMP LLC PRIVACY POLICY**

Last Updated on May 13, 2020

This Privacy Policy explains how information about you is collected, used and disclosed by Velocomp LLC (“Velocomp,” “we” or “us”). This Privacy Policy applies to information we collect when you use our website (the “Site”) or where we otherwise have an official presence, or otherwise communicate with us.

This Privacy Policy is subject to change. If changes are made, we will notify you by revising the “Last Updated” date at the top of this policy and, alternately, we may provide additional notice (by adding a statement to our Site’s homepages or by sending you a notification). We suggest you review our Privacy Policy whenever you visit the Site to stay informed about our information practices and ways you can protect your privacy.

### **Collection of Information**

#### **Information You Provide to Us**

We collect information from you directly. For example, we collect information when you sign up, make a purchase, subscribe to our blog or forum, or add your name to an email list, participate in any interactive features of the Site, communicate with us via third-party social media site, request support, or otherwise communicate with us. The types of information we may collect include your name, email address, city, and any other information you choose to provide.

#### **Information We Collect Automatically**

When you access or use our Site, we automatically collect information about you, including:

- **Login Information:** We log information about your use of the Site, including your Internet Protocol (“IP”) address, access times, pages viewed, web browser, links clicked, and the page you visited before navigating to the Site.
- **Information Collected by Cookies and Other Tracking Technologies:** We and our service providers use various technologies to collect information, including cookies and web beacons.

Cookies are small data files stored on your hard drive or in device memory that help us to improve our Site and your experience, see which areas and features of our Site are popular, and count visits. Web beacons are electronic images that may be used on our Site or in emails and help deliver cookies, count visits, and understand usage and campaign effectiveness. For more information about cookies, and how to disable them, please see “Your Choices” below and our Cookie Policy.

### **Information We Collect From Other Sources**

We may also obtain information from other sources and combine that with information we collect through our Site. If you purchase a product using credentials from a third-party platform, we will have access to certain information about you from that platform, such as your name, account information, in accordance with the authorization procedures determined by such platform.

### **Use of Information**

We may use information about you for various purposes, including to:

- Provide, maintain and improve our Site;
- Send you technical notices, updates, security alerts, and support and administrative messages;
- Respond to your comments, questions and requests, and provide customer service;
- Communicate with you about events, contests, promotions, offers, and other news and information we think will be of interest to you;
- Monitor and analyze trends, usage and activities in connection with our Site;
- Process and deliver contest or promotion entries and rewards;
- Link or combine with information we get from others to help understand your needs and provide you with better service; and
- Carry out any other purpose for which the information was collected.

### **Sharing of Information**

We may share information about you as follows or as otherwise described in this Privacy Policy:

- With vendors, consultants and other service providers who need access to such information to carry out work or perform services on our behalf;
- In response to a request for information if we believe disclosure is in accordance with, or required by, any applicable law, regulation, or legal process;
- Where necessary, if we believe your actions are inconsistent with our user agreements or policies, or to protect the rights, property or safety of Velocomp or others;
- In connection with, or during negotiations of, any merger, sale of company assets, financing or acquisition of all or a portion of our business by another company; and
- With your consent (for example, with our partners for their own marketing purposes if you expressly consent to this type of sharing).

We also may share aggregated or de-identified information, which cannot reasonably be used to identify you.

### **Social Sharing Features**

The Site may offer social sharing features and other integrated tools (such as the Facebook “Like” button), which let you share actions you take on our Site with other media, and vice versa. Your use of such features enables the sharing of information with your friends or the public, depending on the settings you establish with the entity that provides the social sharing feature. ### **Analytics Services Provided by Others**

We may allow others to provide analytics services. These entities may use cookies, web beacons and other technologies to collect information about your use of the Site and other websites, including your IP address, web browser, pages viewed, time spent on pages, links clicked and conversion information. This information may be used by VELOCOMP and others to, among other things, analyze and track data, determine the popularity of certain content, and better understand your online activity.

### **Security**

Velocomp takes reasonable measures to help protect information about you from loss, theft, misuse and unauthorized access, disclosure, alteration, and destruction.

### **Transfer of Information to the U.S. and Other Countries**

Velocomp is based in the United States. By accessing or using the Site or otherwise providing information to us, you consent to the processing and transfer of information about you in and to the U.S. and other countries, where you may not have the same rights under local law.
